**Main hazards:** No significant hazard.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** DODECYL BENZENESULPHONIC ACID SODIUM SALT 10-30%

- COCONUT DIETHANOLAMIDE 1-10%
- /- ANIONIC SURFACTANT 1-10%
