**2. HAZARDS IDENTIFICATION**

**Main hazards:** No significant hazard.

**3. COMPOSITION / INFORMATION ON INGREDIENTS**

**Hazardous ingredients:** ALKYLDIMETHYLBENZYLAMMONIUM CHLORIDE 1-2%

- (C9 - C18)PARETH(2 - 18) <1%
- C10 - C16 PARETH ( 2 - 10 EO ) <1%
